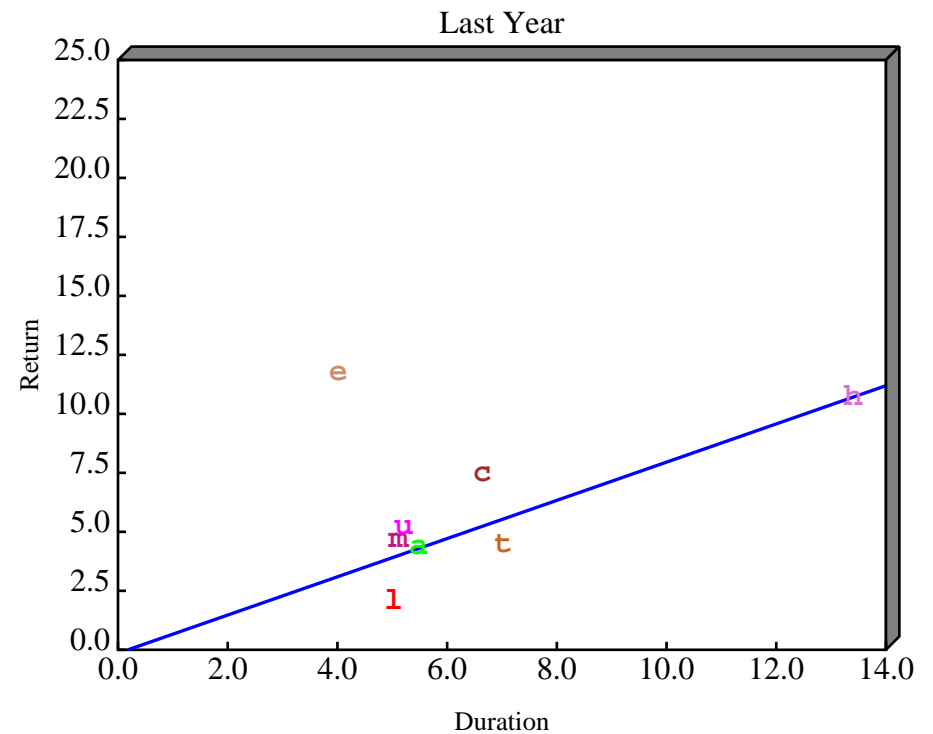
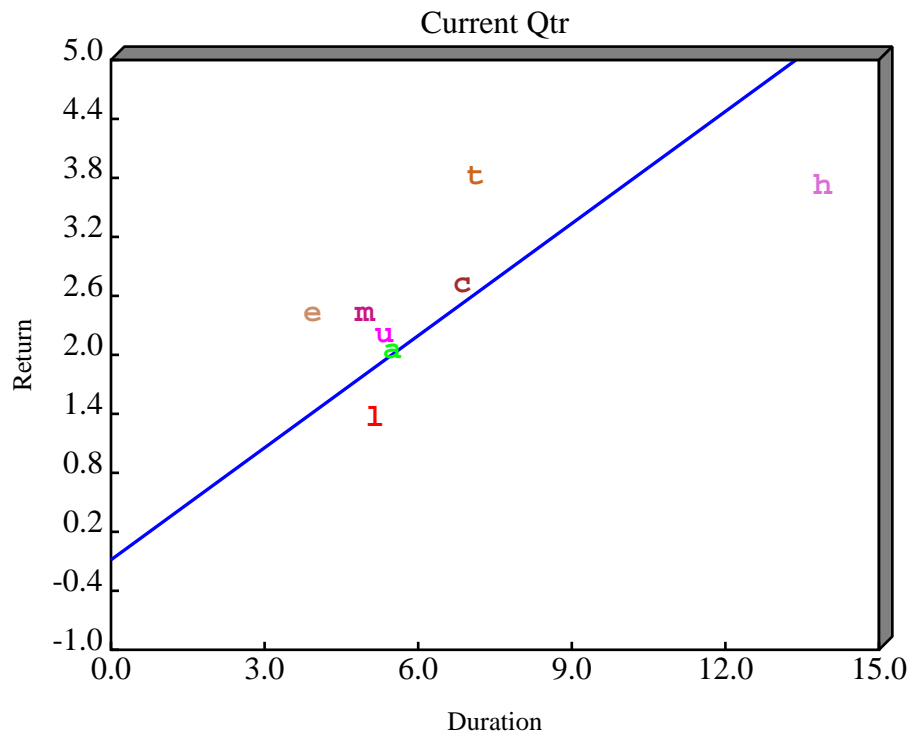
Relative Return

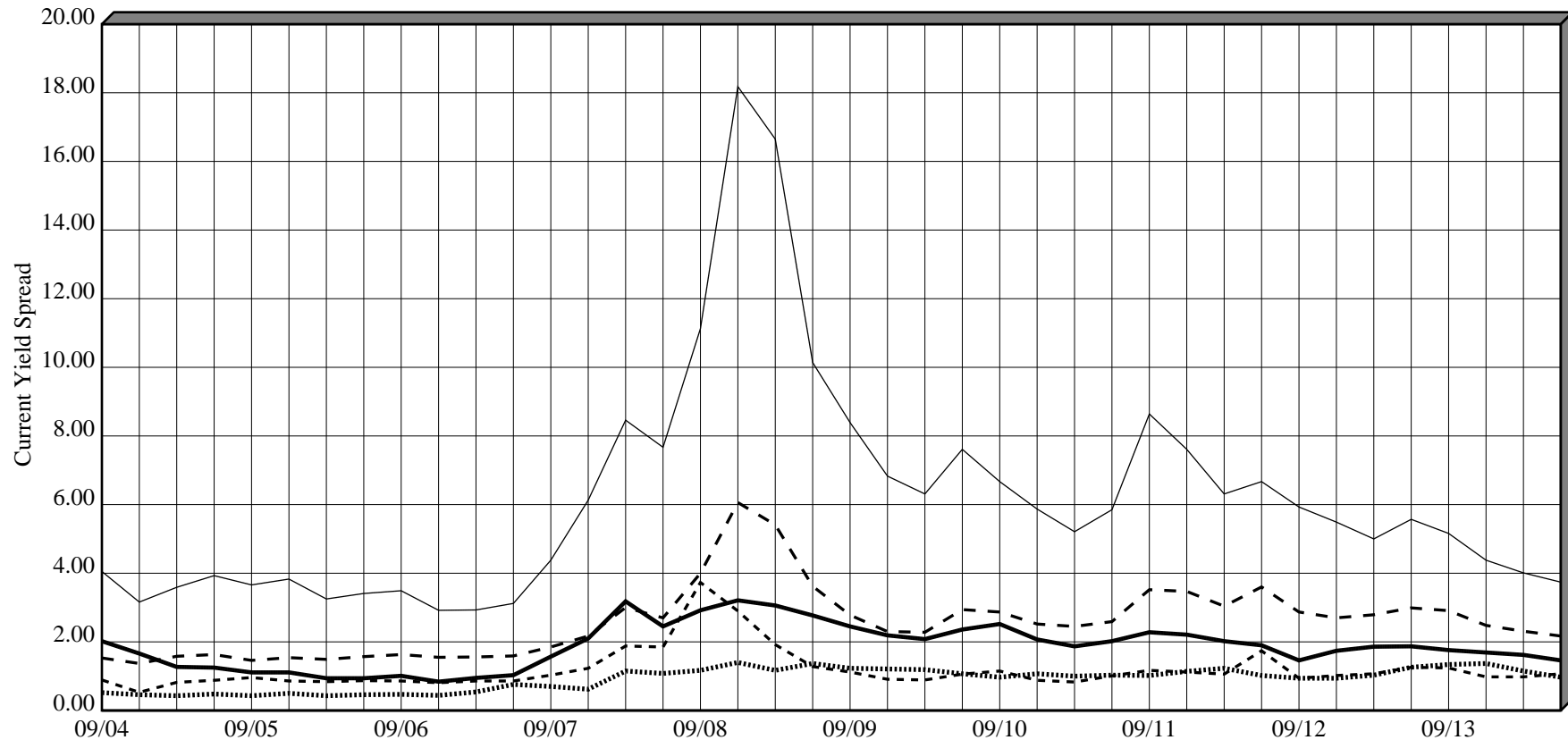

Historical Spread Comparison to Treasuries As of 6/30/14

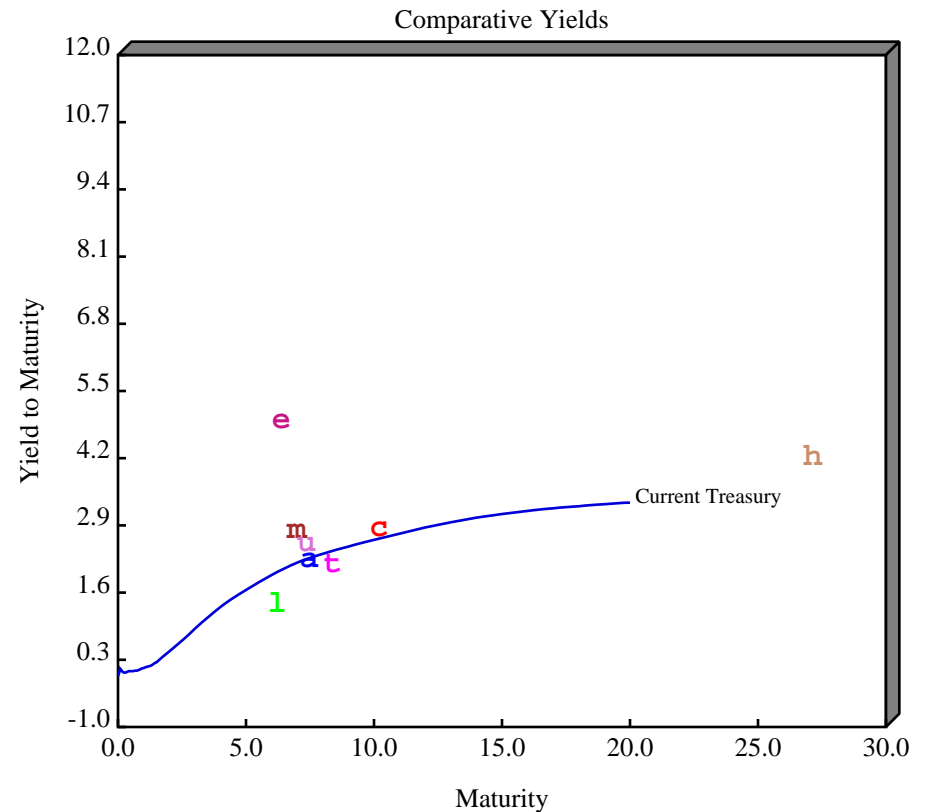
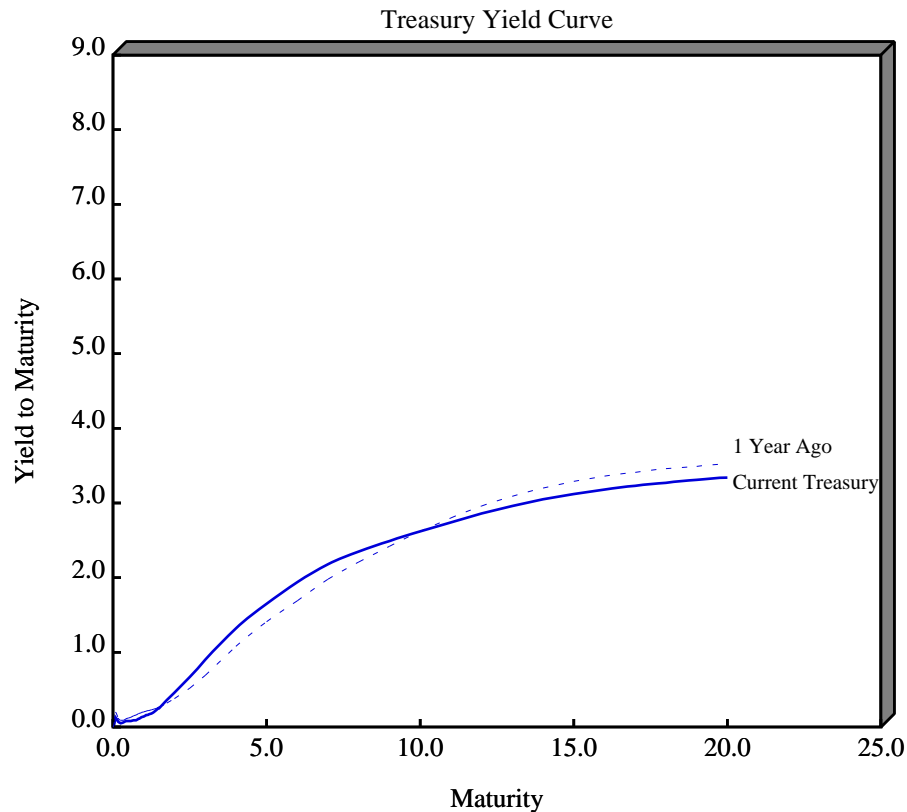

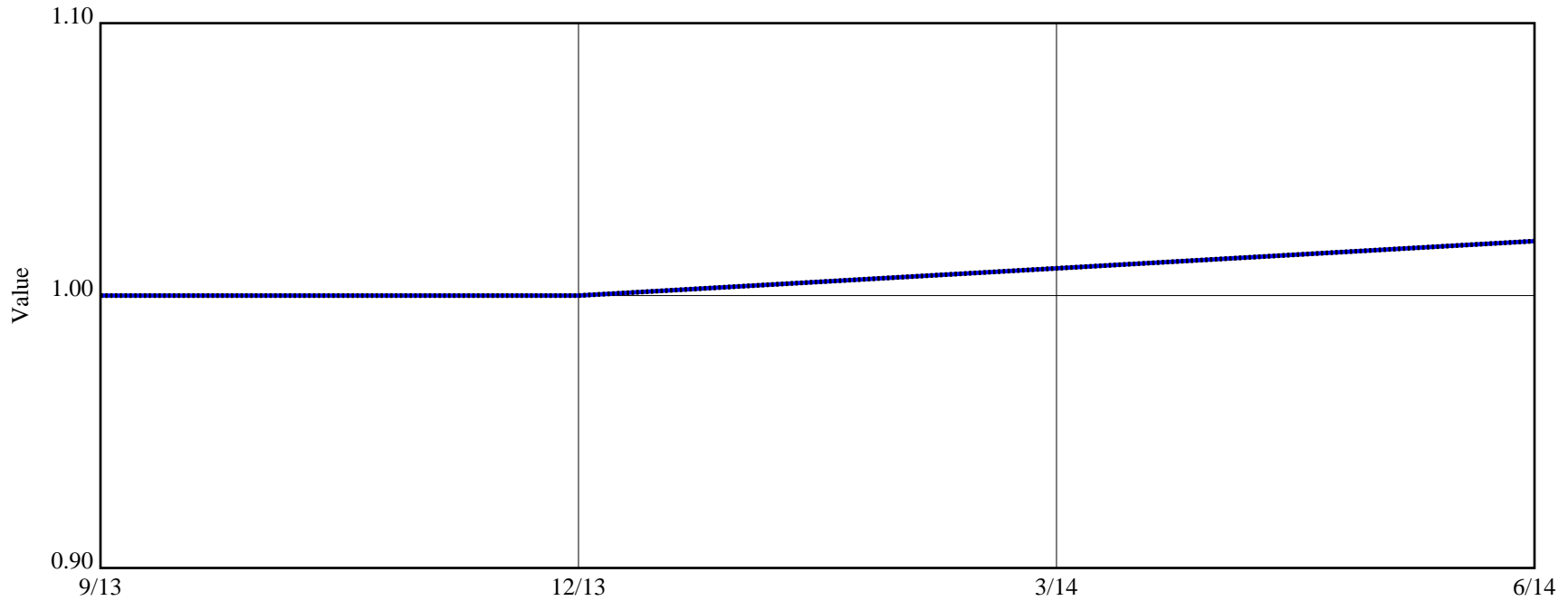
