Dear Governor Inos:

I am writing regarding the Judicial Building Loan ("Loan"). The Loan matured in March 2015, and the entire principal balance of \$4,503,660.86 is now due, together with accrued interest of \$80,501.89 calculated through November 2, 2015. The Settlement Fund has received a total of six payments totaling \$660,285.44 from March 2015 through October 2015. A copy of the Loan ledger is enclosed for your reference.

At an earlier meeting, you asked if the Loan could be refinanced. Because of the challenges Saipan has experienced from the aftermath of Typhoon Sudelor, the Settlement Fund would like to offer the following terms to extend the repayment term of Loan.


The Settlement Fund is willing to extend the repayment terms based on the following terms:

- 1. Principal amount of \$4.503,660.86 will be amortized over a ten (10) year period at the stated rate of interest under the Note of 7.75% interest. Monthly payment will be \$52,014.55. The first payment will be due on December 1, 2015.
- 2. The Government will pay \$250,000 to be applied first to the outstanding accrued interest and then to the principal, by no later than December 1, 2015.
- 3. All other terms and conditions of the loan agreements shall remain in full force and effect.
- 4. The District Court's approves the amendments to the Loan.
