# Market Environment U.S. Common Stocks Relative Return As of 6/30/17

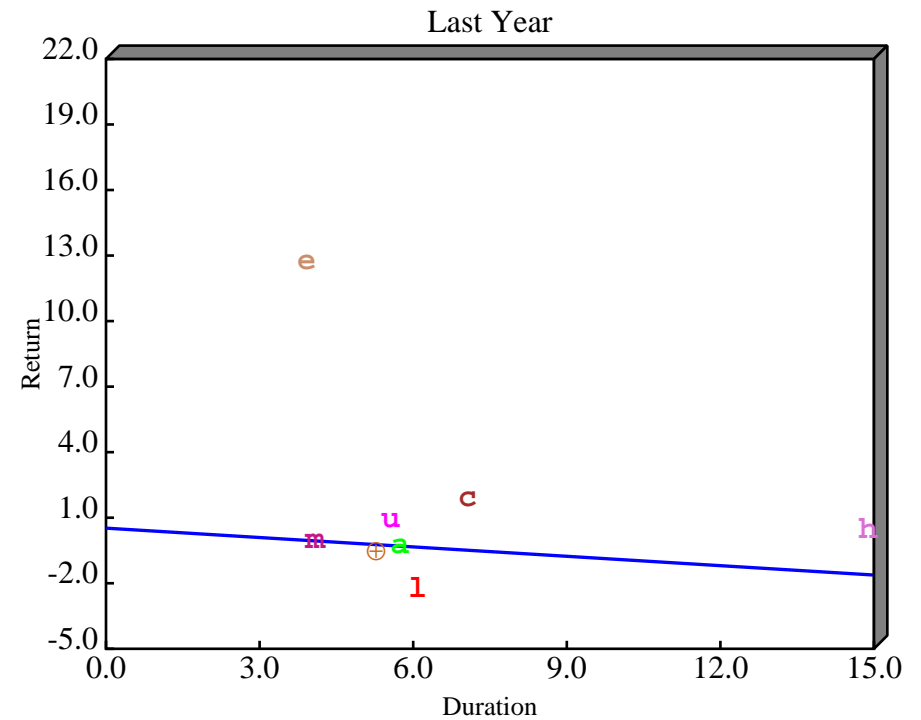
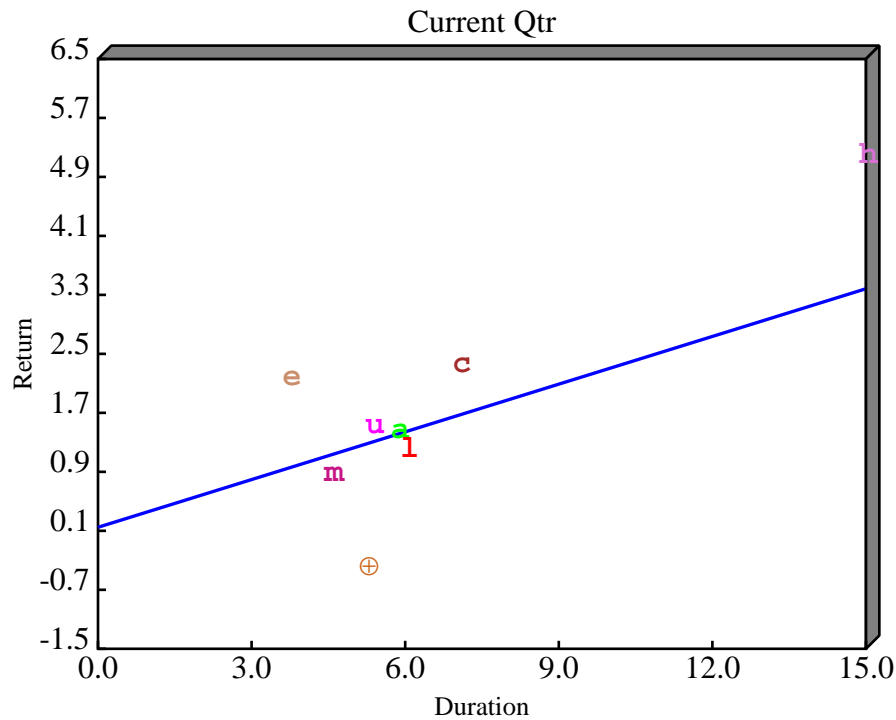
