Market Commentary

Month Ended May 31, 2024

U.S. Economy and Markets

- The broad U.S. equity market was up in May as the FT Wilshire 5000 IndexSM returned 4.72%, with a positive return of 27.59% for the past 12 months.
- Large-cap stocks outperformed their small-cap counterparts for the month, with the FT Wilshire Large Cap IndexSM and the FT Wilshire Small Cap IndexSM returning 4.80% and 4.16%, respectively.
- Performance across GICS sectors was positive in May. Energy and consumer discretionary were the main market laggards while information technology and utilities were the market leaders for the month.

International Economy and Markets

- Developed international equity markets, as measured by the MSCI EAFE Index, returned 3.87% this month. The MSCI Emerging Markets Index produced a gain in May, up 0.56%.
- The U.S. dollar weakened versus advanced foreign economies during the month, resulting in the developed markets' local currency return being lower than those converted back to dollars.

Fixed Income & Real Assets

- Core bonds posted a gain of 1.70% in May as the 10-year U.S. Treasury yield fell 18 basis points.
- High yield corporate bonds were up 1.10% as credit spreads were little changed, up seven basis points in the high yield market. Leveraged loans were up for the month at 0.94%, trailing longer-duration bonds.
- Multiple listed real asset markets were up in May with the Wilshire Global Real Estate Securities IndexSM returning 4.17% and the FTSE Global Core Infrastructure Index up 5.03%.
- Commodities, as measured by the Bloomberg Commodity Index, were up 1.76% in May.

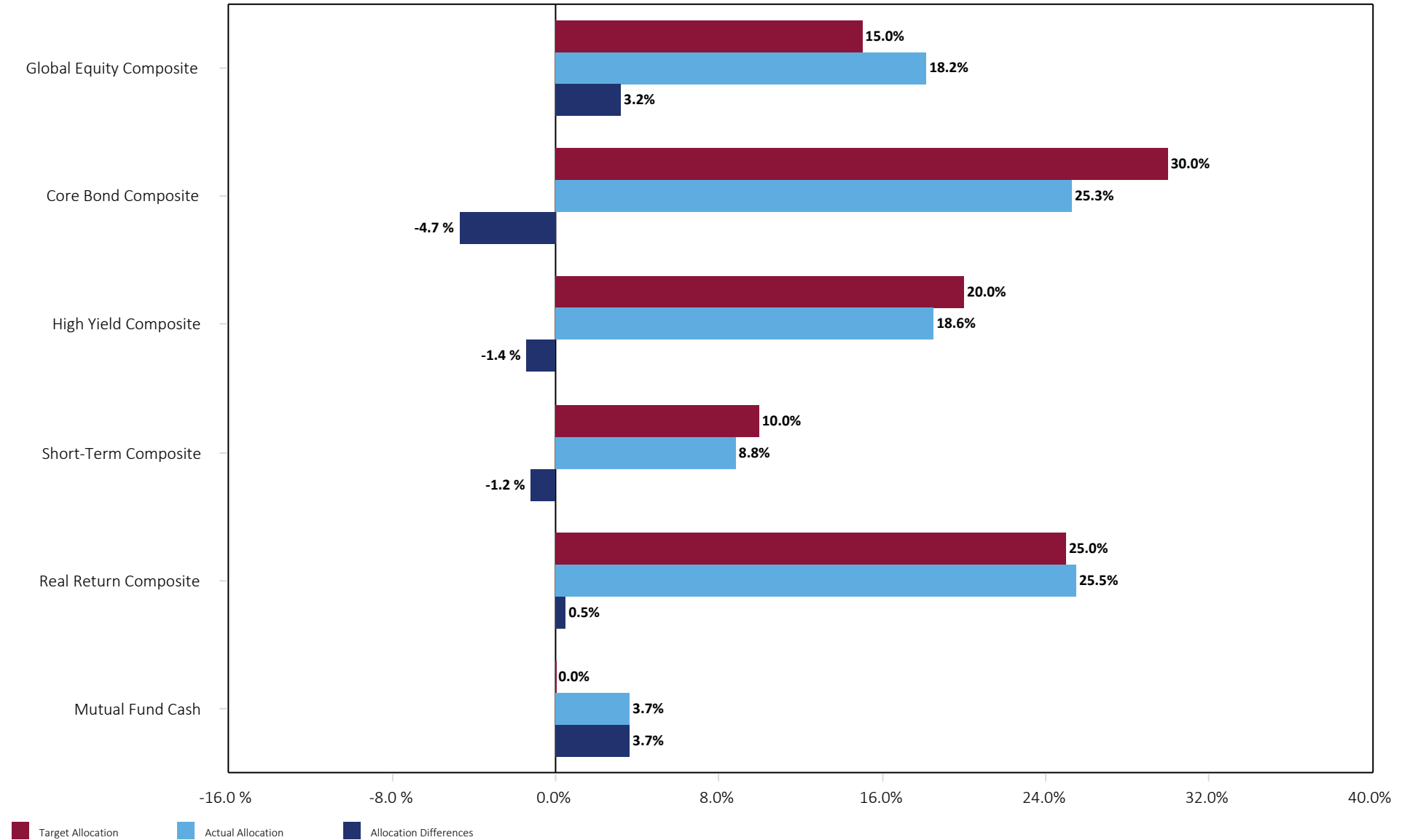
