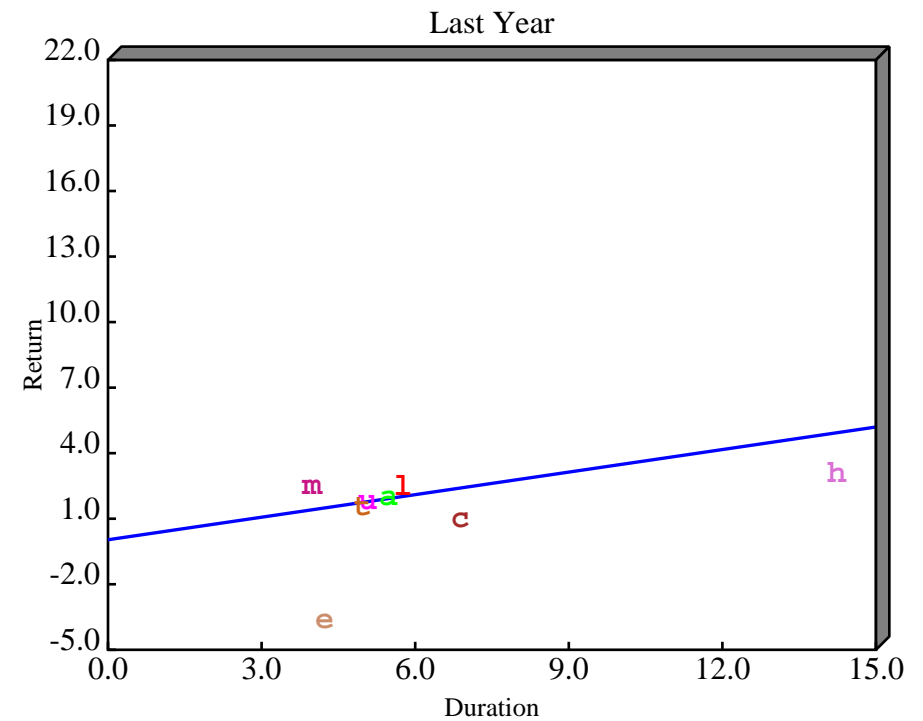
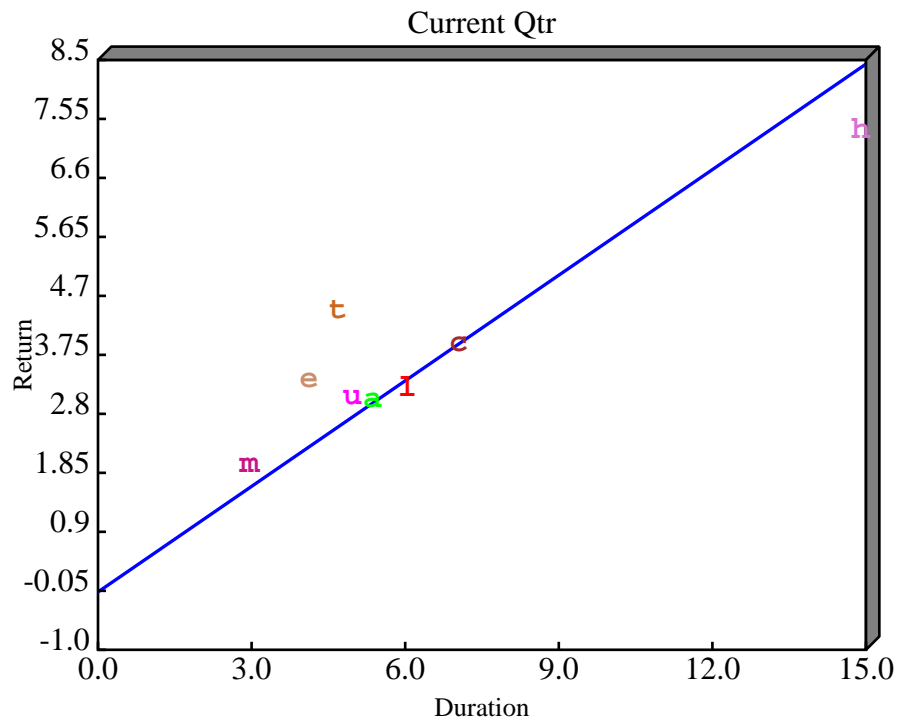
Relative Return  
As of 3/31/16



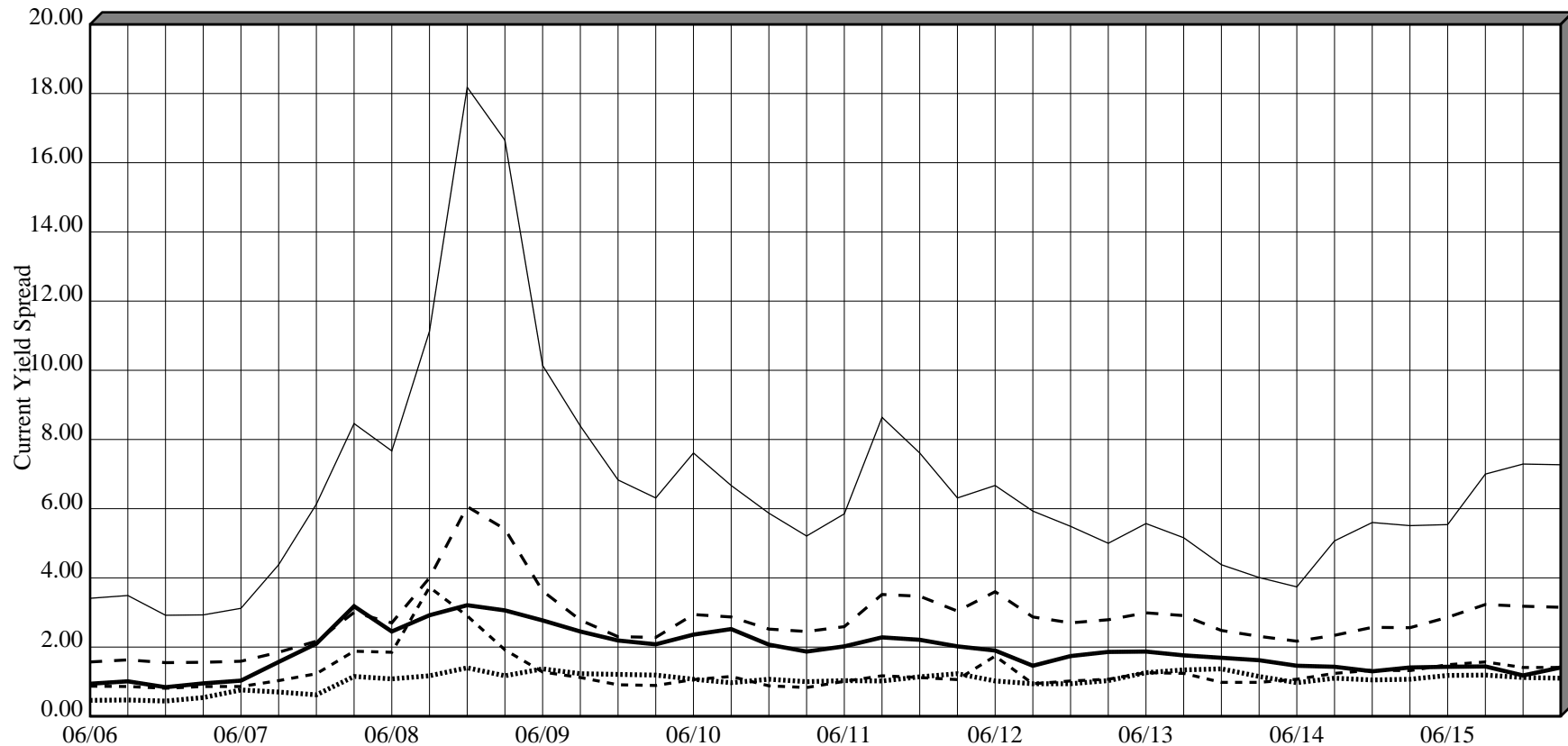

As of 3/31/16



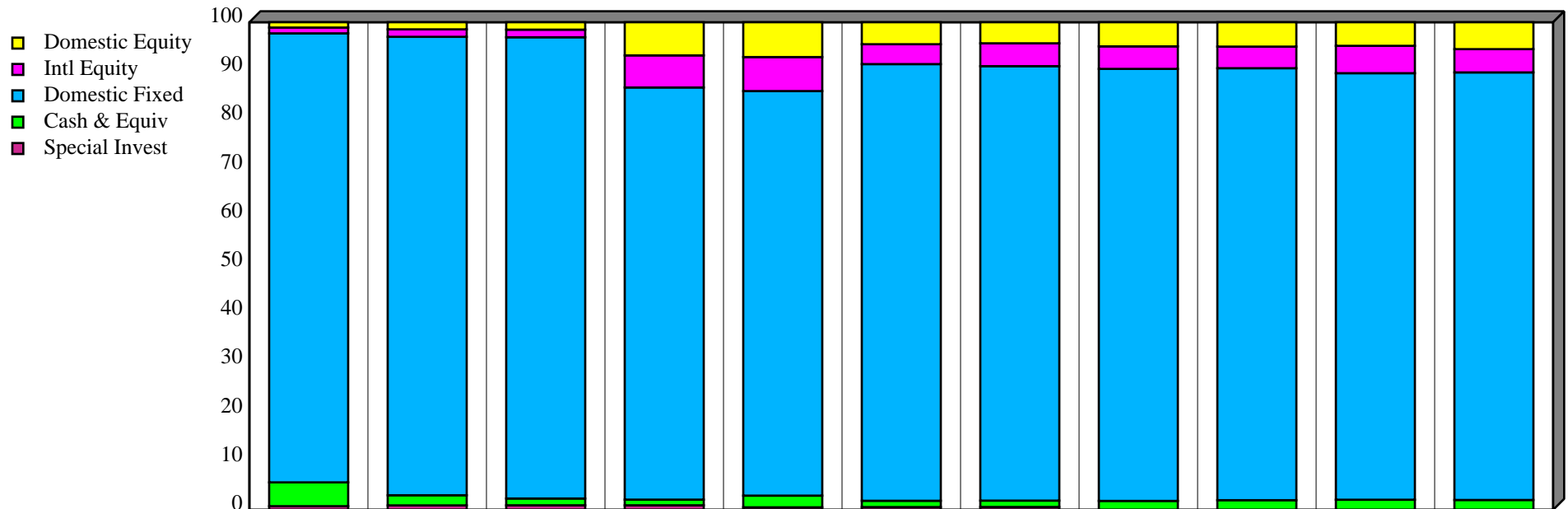

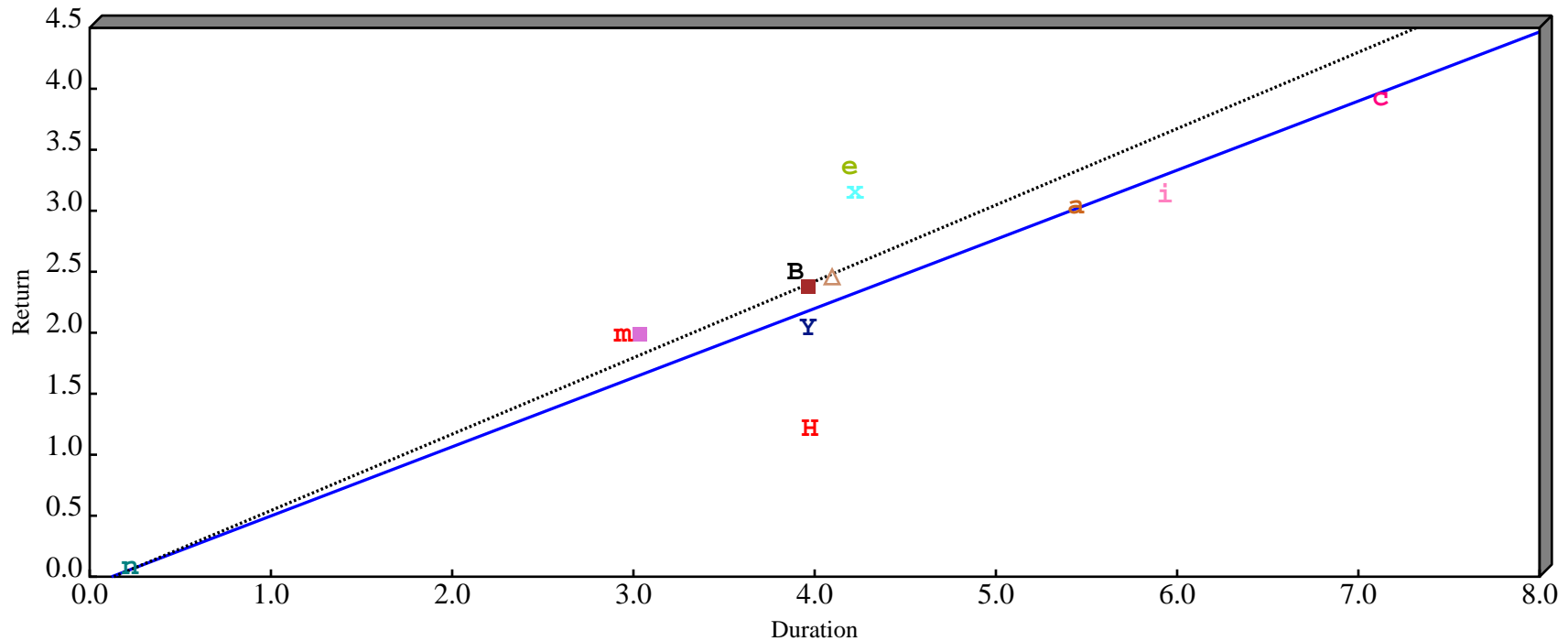

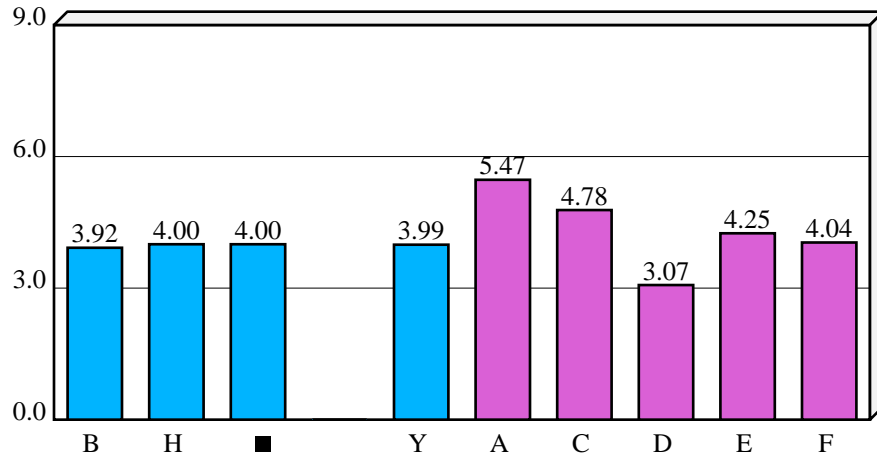
