Market Commentary

Month Ended April 30, 2023

U.S. Economy and Markets

- The broad U.S. equity market was up in April as the FT Wilshire 5000 IndexSM returned 1.04%, with a positive return of 8.40% for the year-to-date.
- Large-cap stocks outperformed their small-cap counterparts for the month, with the Wilshire U.S. Large Cap IndexSM and the Wilshire U.S. Small Cap IndexSM returning 1.29% and -1.83%, respectively.
- Performance across GICS sectors was mixed in April. The consumer staples, communication and health care sectors produced strong gains while industrials was the main laggard.

International Economy and Markets

- Developed international equity markets, as measured by the MSCI EAFE Index, returned 2.82% this month. The MSCI Emerging Markets Index produced a loss in April, down -1.13%.
- The U.S. dollar weakened versus advanced foreign economies during the month, resulting in the developed markets' local currency return being lower than those converted back to dollars.

Fixed Income & Real Assets

- Core bonds posted a gain of 0.61% in April as the 10-year U.S. Treasury yield fell just 4 basis points.
- High yield corporate bonds rose 1.00% as credit spreads tightened 3 basis points. Leveraged loans were positive for the month, also at 1.00%, roughly equaling longer-duration bonds.
- Multiple listed real asset markets were up in April with the Wilshire Global Real Estate Securities IndexSM returning 1.41% and the FTSE Global Core Infrastructure Index up 2.17%.
- Commodities, as measured by the Bloomberg Commodity Index, were down -0.75% in April.

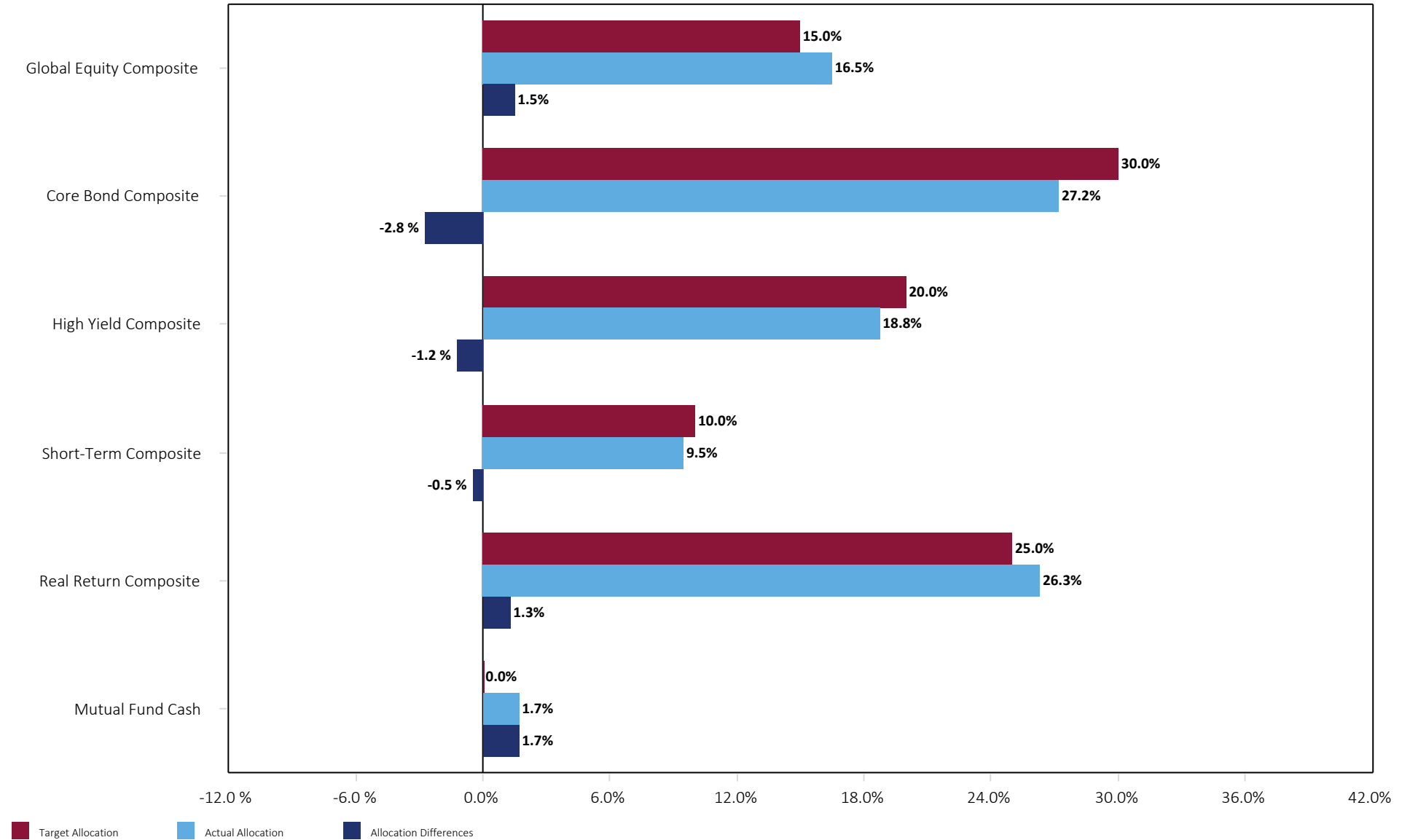
