Market Commentary

Month Ended August 31, 2023

U.S. Economy and Markets

- The broad U.S. equity market was down in August as the FT Wilshire 5000 IndexSM returned -1.94%, with a positive return of 18.13% for the year-to-date.
- Large-cap stocks outperformed their small-cap counterparts for the month, with the FT Wilshire Large Cap IndexSM and the FT Wilshire Small Cap IndexSM returning -1.66% and -3.57%, respectively.
- Performance across most GICS sectors was negative in August. Energy was the only positive sector for the month, while utilities was the main laggard.

International Economy and Markets

- Developed international equity markets, as measured by the MSCI EAFE Index, returned -3.83% this month. The MSCI Emerging Markets Index also produced a loss in August, down -6.16%.
- The U.S. dollar strengthened versus advanced foreign economies during the month, resulting in the developed markets' local currency return being higher than those converted back to dollars.

Fixed Income & Real Assets

- Core bonds posted a loss of -0.64% in August as the 10-year U.S. Treasury yield rose 15 basis points.
- High yield corporate bonds rose 0.28% as credit spreads widened just five basis points. Leveraged loans were positive for the month at 1.17%, leading longer-duration bonds.
- Multiple listed real asset markets were down in August with the Wilshire Global Real Estate Securities IndexSM returning -2.85% and the FTSE Global Core Infrastructure Index down -5.36%.
- Commodities, as measured by the Bloomberg Commodity Index, were down -0.77% in August.

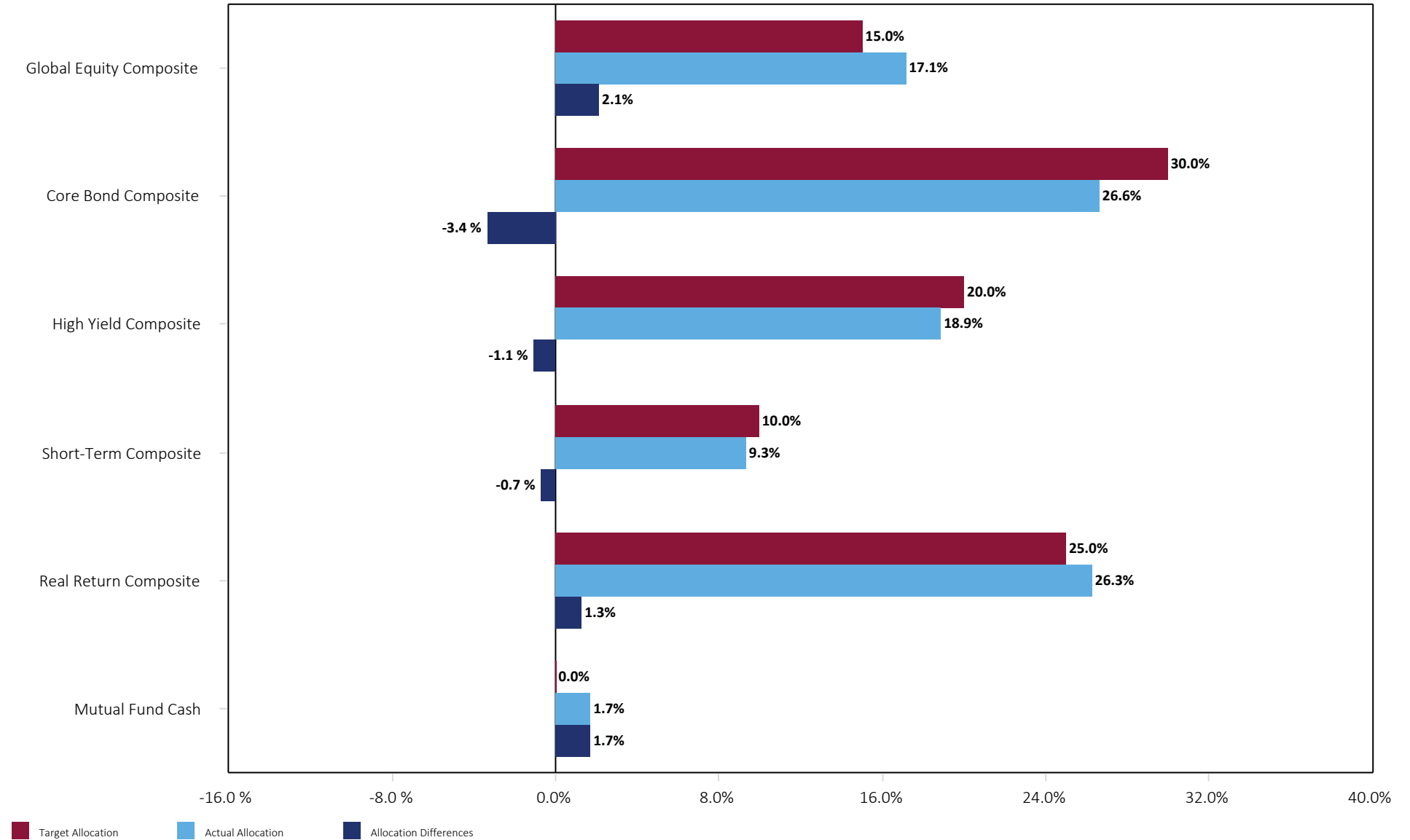
