Market Commentary

Month Ended August 31, 2022

U.S. Economy and Markets

- The broad U.S. equity market was down in August as the FT Wilshire 5000 Index[™] returned -3.79%, with a negative return of -16.63% for the year.
- Small cap stocks performed relatively better than their large cap counterparts for the month, with the Wilshire U.S. Small Cap Index^{sм} and the Wilshire U.S. Large Cap Index^{sм} returning -2.46% and -3.92%, respectively.
- Performance across GICS sectors was mostly negative in August. Real Estate, Technology and Health Care were the worst performing sectors while Energy and Utilities produced positive returns of 3.18% and 0.31%, respectively.

International Economy and Markets

- Developed international equity markets, as measured by the MSCI EAFE Index, returned -4.75% this month. The MSCI Emerging Markets Index produced a small gain in August, up 0.42%.
- The U.S. dollar strengthened versus advanced foreign economies during the month, resulting in local currency returns being better than those converted back to dollars.

Fixed Income & Real Assets

- Core bonds posted a loss of -2.83% in August as the 10-year U.S. Treasury yield rose 54 basis points.
- High yield corporate bonds fell -2.30% as credit spreads widened 15 basis points and the underlying Treasury rates increased. Leveraged loans produced a second consecutive positive month as the short-term reference rate rose.
- Multiple listed real asset markets were down in August with the Wilshire Global Real Estate Securities Index^{sм} returning 6.04% and the FTSE Global Core Infrastructure Index down -1.46%.
- Commodities, as measured by the Bloomberg Commodity Index, were up just 0.09% in August.



Market Commentary

Quarter Ended September 30, 2022

U.S. Economy and Markets

- The U.S. stock market, represented by the FT Wilshire 5000 IndexsM, was down -4.45% for the third quarter and is now down -24.4% for all of 2022.
- Most sectors were down for the quarter. The worst performing were Communication Services (-12.5%), Real Estate (-10.9%) and Materials (-6.7%). The two sectors producing gains were Consumer Discretionary (+4.0%) and Energy (+3.6%).
- From a size perspective, small cap outperformed large by 98 basis points. Growth stocks outperformed value for the quarter but trail meaningfully for the year-to-date.

International Economy and Markets

- Performance results within international equity markets were negative for the third quarter, with developed outperforming emerging markets.
- The MSCI EAFE Index was down -9.4% for the quarter, while the MSCI Emerging Markets Index was down -11.6%.
- In Europe, monetary policy tightening and an energy crisis due, in part, to restricted Russian gas supplies weighed on stocks.
- China is currently struggling on several fronts slowing growth, record high youth unemployment and a collapsing housing market.

Fixed Income & Real Assets

- The U.S. Treasury yield curve was up meaningfully across all maturities during the quarter, with increases ranging from 60 to 165 basis points.
- The 10-year Treasury yield ended the quarter at 3.83%, up 81 basis points from June.
- Credit spreads widened during the quarter within investment grade bonds but tightened, slightly, for high yield bonds, after an outsized jump of 163 basis points in June.
- The Federal Open Market Committee met twice during the quarter, as scheduled, and increased the overnight rate by 0.75% in both July and September, targeting a range of 3.00% to 3.25%.
- Real estate securities were down during the third quarter in both the U.S. and abroad.
- Commodity results also were negative for the quarter, with crude oil falling precipitously by -24.8% to \$79.49 per barrel.


